NOW THIS DEED WITNESSES AS UNDER

1. The Trust Fund shall be a sum of Rs 1000/- (Rupees One thousand only) contributed equally by the Trustees.
2. The third party, Mr Aaron Asok, son of Sri Asokan Raghavan Pillai is admitted to the Trust.
3. The name of the trust shall be ASOKA EDUCATIONAL AND CHARITABLE TRUST and its office shall be situated in at GOVINDAMANGALAM, NADUKKUNNU, PATHANAPURAM - 689 695.
4. The above named Trustees shall be the Trustees for life. The Trustees can co-opt with mutual consent and/or on majority any other person or persons as Trustees. The Total number of Trustees at any time shall not exceed Ten. On the death of any Trustees the remaining Trustees shall appoint a person as a Trustee in place of the deceased. The minimum number of Trustees shall be Three.
3. The investments of the funds of the Trust will be in accordance with the Provisions of Section 11(5) read with section 13(1)(d) of the Income Tax Act.
4. The Trust constituted shall be irrevocable.
5. The powers given to Trustees to effect amendments to the Trust deed, would not extend to altering the basic character/objects of the Trust and further no such amendments which may prove to be repugnant to the provisions of Sections 2(15), 11, 12 & 13 and 80G of the Income Tax Act shall be made.
6. Any amendments to the Trust deed will be carried out only with the prior approval of the Commissioner of Income Tax.
7. The benefits of the Trust are open to all irrespective of caste, religion, creed or sex etc without any kind of discrimination.

- 8 The objectives of the Trust shall be carried out only in India
- 9 The accounts of the Trust shall be regularly maintained and every year, the accounts shall be closed by 31st March and the same shall be audited by a qualified Chartered Accountant.
- 10 The Income and funds of the Trusts will solely be utilized towards the objects of the Trusts and no portion of it will be utilized for payment to the Trustees/members/office bearers by way of profit/dividend/interest etc.
- 11 In the event of dissolution/winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustees/members of the Managing Committee/Governing body but the same shall be transferred to another charitable Trust/Society whose objects are similar to those of the Trust/Institution and which enjoys recognition under Section 12A of the Income Tax Act at the time of transfer or vests with the Government.
- 12 It is hereby specifically state that the trust will not run any business and will not function in the nature of conduction of a business activity for the purpose of profit



13 THE OBJECTS OF THE TRUST

(a) To establish and maintain schools, colleges, vocational training centres, technical professional institutions etc., for imparting quality education in the respective fields and for development of personality to the students.

(b) To establish, develop and maintain hospitals medical/dental colleges, nursing institutions, dispensaries, Maternity homes, Child Welfare Centres and other similar institutions and to grant aid in cash or in kind to such institutions in India for the benefit and use of the general public.

(c) To establish research centers, laboratories and other institutions, for undertaking research in various fields.

The interest and bank of the Total will be credited towards the Total of the Total and no portion of it will be utilized for the purpose of the Total.

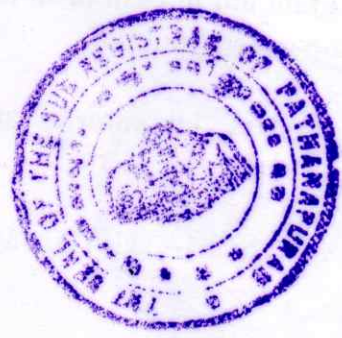
In the event of discontinuance of the Total the assets remaining in the Total shall be distributed and under no circumstances shall the assets be distributed to the members of the Total.

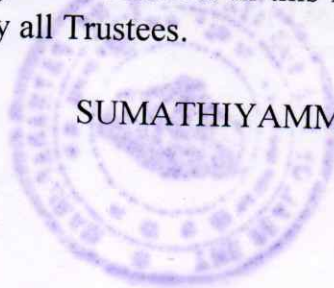

- (d) To institute scholarships and awards and grant loan/advances to deserving students in pursuit of their studies.
- (e) To undertake works for the welfare of the handicapped.
- (f) To establish old age homes for the maintenance and welfare of aged people and generally do all things that are necessary for the welfare of the aged.
- (g) To undertake rehabilitation of weaker sections of the people, especially women by giving them vocational training which will enable them to look after themselves and make them independent members of the society.
- (h) To render assistance to mentally retarded, crippled and other physically handicapped children both directly and/or through institutions engaged in helping their rehabilitation through appropriate therapy, educational, vocational training and other programmes.
- (i) To render assistance to orphaned and other less privileged children for their subsistence, shelter, educational and medical care and to establish social welfare institutions engaged in promoting these specific objectives.
- (j) To generally do all things that are necessary for carrying out the objects of the Trust. It shall be lawful for the trustees to carry out the objects of the Trust either by themselves or by making contributions, donations, grants etc. to any other institution/s, which are established for carrying on any or all the objects of the Trust.
- 14 The Trustees shall have all powers as may be required for the proper conduct of the affairs of the Trust. The trustees shall have the powers to initiate prosecutions and defend legal proceedings as may be reasonable and proper for safeguarding the assets of the properties of the Trust as also the Trust fund and interest. Any Action taken by such Trustees in this regard shall be deemed to have been taken and ratified by all Trustees.




